

**NOTICE TO RIDERS
WAIVER & RELEASE OF LIABILITY**

THIS AGREEMENT DEALS WITH ASSUMPTION OF RISK, AND OPERATES TO LIMIT LIABILITY.

THIS AGREEMENT WILL AFFECT YOUR LEGAL RIGHT, PLEASE READ CAREFULLY.

THE UNDERSIGNED ACKNOWLEDGES THAT HORSEBACK RIDING IS AN INHERENTLY DANGEROUS ACTIVITY WHICH INVOLVES RISKS THAT MAY CAUSE INJURY OR IN SOME CASES DEATH BECAUSE OF THE UNPREDICTABLE NATURE AND IRRATIONAL BEHAVIOR OF HORSES REGARDLESS OF THEIR TRAINING AND PAST PERFORMANCE.

As a condition for the use of the facilities operated by Exmoor Eventing, LLC and the animals provided by Letchworth Farms, LLC.:

THE UNDERSIGNED hereby assumes all risks of personal injury, death or property loss resulting from any cause whatsoever including but not limited to the inherent risks of horseback riding and related activities including unpredictable behavior of the animals, collision with natural or man made objects, falls, dismounts, failure of equipment or otherwise, or negligence, breach of contract, or breach of duty of care on the part of Letchworth Farms, LLC, Exmoor Eventing, LLC, Richard Trayford or Daisy Trayford, their employees, agents and operators, or any one or more of them. The risks include those foreseen and unforeseen, known or unknown.

THE UNDERSIGNED agrees that the operator shall not be liable for any such personal injury, death or property loss and releases Letchworth Farms, LLC, Exmoor Eventing, LLC, Richard Trayford or Daisy Trayford their employees, agents and operators, and waives all claims with respect thereto, except for personal injury, death or property damage resulting directly from the negligence of Letchworth Farms, LLC, Exmoor Eventing, LLC, Richard Trayford or Daisy Trayford..

THE UNDERSIGNED agrees that any litigation involving the operators shall be brought within the State of New York and further agrees that these conditions and any rights, duties and obligations as between the operators and the undersigned shall be governed by and interpreted in accordance with the laws of the State of New York.

THE UNDERSIGNED agrees to adhere to the written and oral instructions of the Letchworth Farms, LLC, its instructors, agents and employees and to act responsibly at all time as a prudent handler of animals.

THE UNDERSIGNED grants Letchworth Farms, LLC, permission to use their likeness in photographs and videos in any and all of its publications, including print or electronic, without payment or other consideration.

SAFETY HELMETS MUST BE WORN BY ALL RIDERS AT ALL TIMES WHILE RIDING ALL RIDERS MUST BE A MINIMUM OF 8 YEARS TO RIDE AND UNDER 250 POUNDS.

In the event that services are provided to a person under the age of eighteen years, the undersigned as authorized legal parent or guardian agrees to indemnify the operators from any and all claims, actions, causes of actions or suits brought by such minor or in his or her name including all defense costs on a attorney-client basis for personal injury, death or property loss resulting to the user of the horses under the age of eighteen years of age.
